Making a complaint - Residential Sales

Your Move Move South Ltd is a member of The Property Ombudsman Scheme (TPOS) and we aim to provide the highest standards of service to all our customers. To ensure that your interests are safeguarded we have the following complaints process in place.

The aim of this process is to resolve all customer issues or concerns as quickly as possible. In the majority of cases we hope that any issues can be resolved quickly and amicably to customers' satisfaction at branch level.

Stage One - Branch Manager

Complaints should, in the first instance be directed to, <Branch Manager> for Your Move Move South Ltd. The Manager will endeavour to liaise with you quickly and resolve your complaint immediately, no later than 5 working days from first notification.

Stage Two - Ryan Oliver, Managing Director

If, after you have dealt with the Branch Manager, you remain dissatisfied you may address your concerns, in writing, to Ryan Oliver. Once received your letter will be acknowledged within 3 working days and you will receive a response within 15 working days from receipt of your letter.

Stage Three - The Property Ombudsman

If you still remain dissatisfied with the outcome of your complaint after dealing with the local branch and Ryan Oliver, once you have received a Final Viewpoint letter from Ryan Oliver, you may approach the Property Ombudsman.

The aim of this process is to resolve all customer issues or concerns as quickly as possible. In the majority of cases we hope that any issues can be resolved quickly and amicably to customers' satisfaction at Manager level.

Stage One - Manager or Team Leader

Complaints should, in the first instance, be directed to Manager or Team Leader at the branch you are dealing with who will endeavour to liaise with you quickly and resolve your complaint immediately, no later than 5 working days from first notification. You can do this verbally, via email or if in writing

Stage Two - Lauren Blake, Operations Director

If, after your response from the Manager or Team Leader, you remain dissatisfied, you may address your concerns, in writing, to Lauren Blake. Once received your letter will be acknowledged within 3 working days, (excluding weekends and public holidays), and you will receive a response within 15 working days from receipt of your letter. If longer is required the complainant will be notified in writing with an explanation and indication of timescale.
